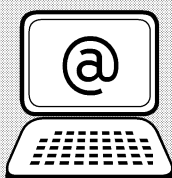

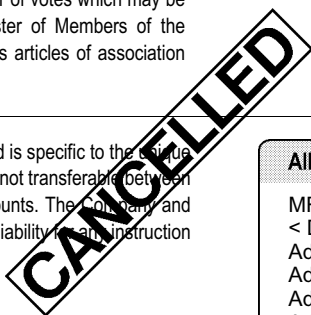
Explanatory Notes:
